Exhibitors Notes

All exhibitors present at this event must be prepared to provide proof of vaccinations for all dogs present at the test site if requested by Pennsylvania State Parks personnel.

If a license is required in its home state, owners must be prepared to present to Park personnel.

EACH EXHIBITOR IS RESPONSIBLE FOR PROVIDING HIS/HER OWN WATER TEST EQUIPMENT, INCLUDING A U.S. COAST GUARD APPROVED PERSONAL FLOTATION DEVICE AND SUITABLE FOOT PROTECTION TO BE WORN IN THE WATER.

These Newfoundland Water Tests are sanctioned by the Working Dog Committee (WDC) of the Newfoundland Club of America and sponsored by the Penn-Ohio Newfoundland Club and all tests will follow the NCA's Water Test Regulations copyrighted in 1999 and updated in March 2018. Entrants are responsible for obtaining and reading the regulations governing NCA Water Tests. A copy of the official Water Test Regulations may be found on line at https://www.ncanewfs.org

PONC Safety Observances

- 1. Dogs must be crated or on leash at all times.
- 2. When on leash, the length of the leash must not exceed SIX feet and may NOT be a retractable leash.
- 3. When on leash, dogs must be under control at all times.
- 4. Dogs showing uncontrolled or aggressive behavior will be asked by the event chair, a board member, safety officer or other official to leave the site promptly or be crated for the duration of the event.

PHOTOGRAPHY

Please note: PONC photographers are on site as **spectators and volunteers.** They have many other duties in addition to recording the PONC tests for the club. **They are not required nor expected** to take photos of all dogs. If exhibitors or others want to ensure that photos are taken of their dog(s) during tests weekend, please designate a person to use a cell phone or other recording device.

The Water Rescue Test

The NCA Water Tests are a series of exercises designed to develop and demonstrate the abilities of purebred Newfoundland dogs in an aquatic environment. NCA water tests demonstrate natural ability and skills acquired through training, and emphasize teamwork between dog and handler in simulated work and rescue situations. The ideal working relationship is a balance of controlled performance and natural independence. Dogs should display not only efficiency in accomplishing their tasks, but also willingness and enjoyment in their work.

Dogs Eligible to Compete:

The NCA Water Rescue Tests will be open to purebred Newfoundland dogs at least six (6) months of age. The word 'dog' in the NCA Water Rescue Test Regulations refers to either sex. All entered dogs must have an AKC/CKC registration number, AKC ILP/PAL number, foreign registration number, or AKC or foreign litter number.

BITCHES IN SEASON may participate in NCA Water Rescue Tests. Bitches in season will be tested at the end of the competition after all male dogs are judged. When not being tested, bitches in season must be contained in a designated area well away from male dogs and the official test areas.

DOGS NOT BEING TESTED AT THE TIME are not permitted in the official Test Areas.

UNENTERED DOGS (except bitches in season) are welcome to join us at the test site. Please remember that all unentered dogs must remain well away from the main test area during judging so as not to disturb any competing dogs.

Site Description:

The test is held in a portion of Pymatuning State Park made up of approximately 10 acres adjacent to the Dam. Included are two beaches, a wooded area, a park pavilion, and a large grassy area. The woods are within 60 feet of the water's edge on the left side of the site and within 30-40 feet on the right side of the site. The test site has a sand and gravel beach approximately 80 feet wide and 10-15 feet deep with a grassy area between the beach and woods. Water depth increases gradually as you move in to the lake. The lakebed slopes from left to right as you face the lake and is mostly sand and rock near shore, changing to rocks or mud 20-30 feet from shore. At normal water levels, dogs begin to swim 15-20 feet from shore on the left and 10-15 feet from shore on the right of the site. The water becomes cloudy as dogs enter but quickly clears. The site has experienced strong breezes in the past, usually blowing left to right, but occasionally swinging directly to shore. Very strong winds have produced white cap waves of 3-12 inches in height.

COVID GUIDELINES:

All participants will be required to sign a Covid-19 waiver, for each day of the test, assuming all risks related to potential exposure to Covid -19 and will be issued an armband. All participants must maintain 6 feet of distance from all others. If you have a fever, are not feeling well or have had contact with a known Covid-19 positive individual within 48 hours of the test, we ask that you contact the test secretary immediately and do not attend the test. Covid-19 check in procedures will be provided to each exhibitor in their final entry confirmation letter. We will be following the State of Pennsylvania and any Federal guidelines for additional mask wearing and social distancing. Please note these guidelines are subject to change and are provided on current local, state and federal Department of Public Health Guidelines. You will be informed of any changes as the test date approaches.

For all Tests, priority will be given to entries that have not earned titles in the division entered. Paper entries must be submitted on an NCA entry form, with a copy of the dog's current AKC, CKC, ILP/PAL or foreign registration with a legible number.

Entries submitted electronically will be assigned a postmark with the same date the entry is entered. Entries submitted by mail will be assigned the postmark given as per usual. Entries submitted electronically and via post will be considered equally in date order for slots in the test. NCA members will have the same early-entry window with both paper entry and electronic entry.

If you are not a member of the NCA you will be prompted to provide the same contact information that you would provide on a paper entry once entries are open to non-NCA members. You will be prompted to enter or verify your dog's information and you will have the opportunity to upload an image of your dog's registration certificate. Please have an electronic version of your dog's registration certificate ready for upload before you begin the online entry process. Entry slots will be filled according to postmark date. In the event that the number of entries with the same postmark date received exceeds the limit, vacancies will be filled and alternates will be determined by a random drawing for each day. Entries received after the entry limit has been reached will be placed on an alternate list in order of postmark. Alternates will be notified immediately should an opening occur.

NO ENTRIES will be accepted with a postmark prior to: June 13, 2022 (NCA member) or June 23, 2022 (Non-NCA member)

ENTRIES CLOSE on Friday, July 8, 2022 at the test secretary's home at 5:00 P.M. After which time, entries cannot be accepted, canceled, altered or substituted. If entries exceed daily allotted positions a lottery will be conducted and an alternate list will be made.

Online Entry is highly recommended as USPS is experiencing a significant slow down in delivery with reports of first class mail taking 10days or longer for delivery. If you choose to mail your entry, please do so as early as possible to avoid entries received too late due to delivery time frames.


